

Comparative Effectiveness Research on Psychiatric Hospitalisation by Record Linkage of Large Administrative Data sets (CEPHOS-LINK).

A European research project investigating psychiatric services across six countries, namely Finland, Austria, Romania, Norway, Slovenia and Italy from April 2014 to March 2017.

CEPHOS-LINK in a nutshell

Despite psychiatric services having undergone profound changes over the last decades, psychiatric hospital admission and re-admission rates remain high.

Repeated hospital admissions constitute significant interruption in patients' lives and frequent or unplanned readmissions can be regarded as an indicator of poor or inefficient psychiatric care.

A reduction in repeated hospital admissions can be considered a positive, patient centred outcome, and in order to achieve this we need further clarity around psychiatric rehospitalisation and all it entails.

CEPHOS-LINK will use state-of-the-art approaches using large 'real world' electronic databases in six different countries, allowing for specific comparisons and detailed analyses to be made.

Results from CEPHOS-LINK will benefit a broad range of stakeholders such as the scientific community, health service planners and decision makers through reports, recommendations, guidelines, policy briefs and an online decision support tool.
